The calls in the City of Wewahitchka limits are about 25% of the calls. There were 61 traffic stops in City limits.

City Engineers – Engineer Hunter Baumgardner stated we have received the AUGF (Authority to Use Grant Funds) for waterlines. Engineer Baumgardner requested contingent approval to go out for bid for the waterline project once Florida Commerce approves bid documents.

Engineer Baumgardner stated they are working on the survey on storm sewer and environmental assessments on waste water and storm sewer.

Sheriff Mike Harrison requested permission to speak stated they are getting complaints on speeders on Jehu Rd. Sheriff's Office will monitor it for the next month, and will report back to the board, the board may want to a consider 3 way stop.
