Mayor Gaskin asked City Engineer Hunter Baumgardner and City Engineer Jack Husband to check the bids for compliance. Upon review, Engineer Husband stated the bid he had was Monolith Construction and they did not have the bid bond filled out. Engineer Hunter Baumgardner stated that Anderson Construction's bid appears to be in compliance.
