

**AN ORDINANCE AMENDING AND SETTING THE RATES TO BE CHARGED FOR MUNICIPAL WATER AND SEWER SERVICES FOR RESIDENTIAL AND COMMERCIAL USE AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the City of Wewahitchka has found a scrivener's error regarding sewer rates in the original Ordinance 2008-1046L dated October 27, 2008, and recorded November 5, 2008, in Official Records Book 466, Page 950, Gulf County, Florida;

NOW, THEREFORE, be it ordained by the people of Wewahitchka, Florida, that Ordinance 2008-1046L is corrected to read as follows and replaces the ordinance dated October 27, 2008:

WHEREAS, the City of Wewahitchka has maintained water and sewer systems as required by the State of Florida for several years; and

WHEREAS, the maintenance expenses have increased over the years; and

WHEREAS, the City of Wewahitchka must meet several state mandates for water and sewer systems;

NOW, THEREFORE, BE IT ORDAINED by the people of Wewahitchka, Florida, that:

SECTION 9 of Ordinance No. 11-14-89-1; Ordinance No. 6-10-91-2; Ordinance No. 12-3-91; Ordinance No. 2003-08-11; and Emergency Ordinance No. 2003-1001L are hereby amended and changed to reflect increased water and sewer rates as set forth below:

**SECTION 9: RATES**

A. The rate schedule is hereby adopted by the Commission providing for the following residential and commercial water user rates:

<u>Water</u>	<u>Rates</u>
From 0 to 2,500 gallons	\$13.50 per month (minimum bill)
All over 2,500 gallons	\$ 4.50 per 1,000 gallons Or portion thereof

B. All users and persons, whether residential or commercial, required to utilize city water and/or sewer systems shall pay a monthly rate per consumer for sewer services as follows:

<u>Sewer</u>	<u>Rates</u>
From 0 to 5,000 gallons of water used	\$28.15 per month (minimum bill)
All over 5,000 gallons of water used	\$ 4.50 per 1,000 gallons Or portion thereof

C. The City reserves the right to enter into contracts with large users of water and/or sewer service for the purpose of setting and determining a monthly charge or rate for the use of such services, which monthly rate or charge may be computed upon

a different basis than set forth in the paragraph immediately preceding. Such contracts shall be entered into by means of resolution duly adopted by the City Commission.


All ordinances or parts of ordinances and all sections or parts of sections of the Code of Ordinances of the City of Wewahitchka in conflict herewith are hereby repealed.

This Ordinance shall become effective November 1, 2008, with the billing to begin on the new rates with the November 2008 use that is billed and mailed in December 2008.
