



## **2025 Annual Drinking Water Quality Report** City of Wewahitchka

We are pleased to announce that our drinking water meets all federal and state requirements.

*We're pleased to present to you this year's Annual Water Quality Report. This report is designed to inform you about the quality water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water. Our water source is ground water from two wells. The wells draw from the Floridan Aquifer. Because of the excellent quality of our water, the only treatments required are chlorine for disinfection purposes and aeration for removal of hydrogen sulfide.*

*The City of Wewahitchka routinely monitors for contaminants in your drinking water according to Federal and State laws, rules, and regulations. Except where indicated otherwise, this report is based on the results of our monitoring for the period of January 1 to December 31, 2025. Data obtained before January 1, 2025 and presented in this report are from the most recent testing done in accordance with the laws, rules, and regulations.*

*In the table below, you may find unfamiliar terms and abbreviations. To help you better understand these terms we've provided the following definitions:*

**Maximum Contaminant Level or MCL:** *The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.*

**Maximum Contaminant Level Goal or MCLG:** *The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.*

**Action Level (AL):** *The concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.*

**Maximum residual disinfectant level or MRDL:** *The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.*

**Maximum residual disinfectant level goal or MRDLG:** *The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.*

**Parts per million (ppm) or Milligrams per liter (mg/l)** – *one part by weight of analyte to 1 million parts by weight of the water sample.*

**Parts per billion (ppb) or Micrograms per liter (µg/l)** – *one part by weight of analyte to 1 billion parts by weight of the water sample.*

**Picocurie per liter (pCi/L)** - *measure of the radioactivity in water*

**“ND”** *means not detected and indicates that the substance was not found by laboratory analysis.*

*Lead can cause serious health effects in people of all ages, especially pregnant people, infants (both formula-fed and breastfed), and young children. Lead in drinking water is primarily from materials and parts used in service lines and in home plumbing. The City of Wewahitchka is responsible for providing high quality drinking water and removing lead pipes but cannot control the variety of materials used in the plumbing in your home. Because lead levels may vary over time, lead exposure is possible even when your tap sampling results do not detect lead at one point in time. You can help protect yourself and your family by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. Using a filter, certified by an American National Standards Institute accredited certifier to reduce lead, is effective in reducing lead exposures. Follow the instructions provided with the filter to ensure the filter is used properly. Use only cold water for drinking, cooking, and making baby formula. Boiling water does not remove lead from water. Before using tap water for drinking, cooking, or making baby formula, flush your pipes for several minutes. You can do this by running your tap, taking a shower, doing laundry or a load of dishes. If you have a lead service line or galvanized requiring replacement service line, you may need to flush your pipes for a longer period. If you are concerned about lead in your water and wish to have your water tested, contact the City of Wewahitchka. *The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.*

*Contaminants that may be present in source water include:*

- (A) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.*
- (B) Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.*
- (C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.*
- (D) Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.*
- (E) Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.*

*In order to ensure that tap water is safe to drink, the EPA prescribes regulations, which limit the amount of certain contaminants in water provided by public water systems. The Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.*

*Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. *Thank you for allowing us to continue providing your family with clean, quality water this year. In order to maintain a safe and dependable water supply, we sometimes need to make improvements that will benefit all of our customers. These improvements are sometimes reflected as rate structure adjustments. Thank you for understanding.*

*The Federal Environmental Protection Agency has revised the Lead and Copper rule for all public drinking water systems. They have mandated that drinking water systems produce an inventory list of all service line material. The service line is the piping that extends from our water main to the customer's meter as well as the piping that extends from the meter to the customer's home. The City of Wewahitchka has prepared this inventory in accordance with federal regulations. To view this service line inventory, contact the City of Wewahitchka or visit :*

*Corrosion of pipes, plumbing fittings and fixtures may cause metals, including lead and copper, to enter drinking water. To assess corrosion of lead and copper, conducts tap sampling for lead and copper at selected sites yearly. The most recent set of lead and copper tap sampling is available for review. To view the lead and copper tap sampling data, contact the City of Wewahitchka.*

***Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections.
